Report on Annual Members Meeting LLMC's 40th Annual Members Meeting was held at AALL in Austin on July 17. Items on the Agenda included: Board approval of a **2% increase in Membership subscriptions effective in 2018** to support content growth and operating expenses; interface update; successful relocation of production to MN; content highlights such as Houston Mutiny of 1917, Early State Records thanks to Patron Libraries, CRL's US state legislative journals, more international content: Cuba, Canada, Latin America, United Kingdom, also 7th Circuit records and briefs. Richard Amelung's *Haiti Bibliography* received prestigious AALL Andrews Award! The principal business of the annual meeting was elections for LLMC's two governing bodies, our Board of Directors and Advisory Council. Voting rights for delegates reflected each library's subscription status relative to LLMC Digital.

◆ Elections 2017

In the Board of Directors election two four-year slots were open due to the expired terms of **Anne Matthewman**, Dir., Dalhousie Univ LL, and **Judy Russell**, Dean, Univ of FL Libraries. The Board of Directors nominated Anne, in recognition of her service and expertise as Co-Chair of the Finance Committee, and **Barbara Dewey**, Dean, Penn State University Libraries. No other nominations being made, the Board's nominees were elected by acclamation. Barbara is the first LLMC Board Member also serving on CRL's Board.

The Board created two Emeritus positions: **Kent McKeever**, Dir, Columbia Univ LL in support of Early State Records initiative and **Judy Russell**, Dean, Univ of FL Libraries to lead development of the Cuba Collection.

The following of our colleagues were nominated and elected or reelected, to the Advisory Council by acclamation.
