Report on Annual Members Meeting

LLMC's 41st Annual Members Meeting was held at AALL in Baltimore on July 16. Key items on the Agenda: Board approved a **2% increase in Membership subscriptions effective in 2019**; new document viewer coming in Fall; Early State Records #1 Collection searched; 50-state legislative journals completed; more content for Canada, Latin America, Germany, Cuba, US States etc. The principal business of the annual meeting was a final vote on conversion from Hawaii to Minnesota 501c3 and elections for LLMC's two governing bodies, our Board of Directors and Advisory Council. Voting rights for delegates reflected each library's subscription status relative to *LLMC Digital*.

◆ Elections 2018

In the Board of Directors election two four-year slots were open due to the expired terms of **Jules Winterton**, Exec. Dir. & Libn., I.A.L.S., and **Richard Amelung**, Prof. Emer., St. Louis U.L.L. The Board of Directors nominated Richard for another term in recognition of valued service as Chairman and expertise, especially with regards to managing bibliographic initiatives. **Beth Williams**, Dir. Stanford U.L.L., was nominated to replace Jules. The Board's nominees were elected by acclamation.
