

Report on Annual Members Meeting

LLMC's 46th Annual Members Meeting was held on July 17 in Boston. **Future Annual Members Meeting will be virtual to support global participation.** Key items on the Agenda: Board approved **3% increase in LLMC membership rates effective January 2024**; Board approved new membership charge of **\$2,000 for Category A universities with law schools** to assist with increased demand for digitization and preservation effective January 2024; Early State Records (ESR), CMR and MA Register, Records and Briefs; Indigenous Law; expanding foreign coverage (177 countries, 69 languages): Canada, United Kingdom, Latin America, Germany, Caribbean, Africa, Eastern Europe and Russia; partner updates, including Google and Library of Congress. Election results were confirmed for LLMC's two governing bodies, our Board of Directors and Advisory Council. Voting rights for delegates reflected each library's subscription status relative to *LLMC Digital*.

◆ Elections 2023

In the Board of Directors election, two four-year slots were open due to the expired terms of **Lyonette Louis-Jacques**, For. & Int'l Law Libn., U. Chicago U.L.L., and **Suzanne Young**, Libr. Services Mngr., Jones Day. The Board nominated **Kincaid Brown**, Dir, Univ of Michigan L.L. and **Kim Nayer**, Dir, Cornell Univ LL. Board nominees were elected by electronic ballot.

In the Advisory Council elections, six councilors' terms expired. Four were nominated to serve another term and reelected by electronic ballot: **Alex Burdett**, Ref/For & Int'l Law Libn., NY School of Law Lib, **Mary Hemmings**, Dir, Thompson Riv U.LL, **Ivo Vogel**, Intr'l and Interdisciplinary Legal Research, Staatsbibliothek zu Berlin - Preußischer Kulturbesitz, and **Jean Wenger**, Dir., Chicago-Kent LL. In addition, the Board nominated former Board member **Lyonette Louis-Jacques** For. & Int'l Law Libn., U. Chicago L.L. to chair an Outreach Committee, **Marisol Floren-Romero**, For. & Int'l Law Libn., Florida International Univ. L.L., **Rebecca Plevel**, Reference Libn., Univ. Of South Carolina L.L., and **Marcelo Rodriguez**, For. Comparative, & Int'l Law Libn., Univ. of Arizona L.L. Council nominees were elected by electronic ballot.
