Report on Annual Members Meeting

LLMC's 38th Annual Members Meeting was held at AALL in Philadelphia on July 20. Items on the Agenda included: news that a recent vote resulted in unanimous ratification of changes to By-laws; Board approval of a **2% rate increase in Membership subscriptions effective in 2016** in line with COLA; and results from the Member Survey, which will be posted on LLMC's website www.llmc.com and inform us that 76% of the 88 respondents are actively divesting print. The principal business of the annual meeting was elections for LLMC's two governing bodies, our Board of Directors and Advisory Council. Voting rights for delegates reflected each library's subscription status relative to *LLMC Digital*.

Elections 2015

In the Board of Directors election two four-year slots were open due to the expired terms of **Regina Smith**, Dir., Jenkins Memorial Law Library, and **Joe Hinger**, Dir. Tech Serv., St. John's U.L.L. The Board of Directors nominated Regina and Joe for another term in recognition of their substantive service and expertise, especially with regards to current organization initiatives. No other nominations being made, the Board's nominees were elected by acclamation.
