

Report on Annual Members Meeting

LLMC's 45th Annual Members Meeting was held on July 15 in Denver. Key items on the Agenda: Board approved **3% increase in LLMC membership rates effective in 2023**; Early State Records (ESR), CMR and MA Register, more Records and Briefs; Indigenous Law and RIGHTS! Portals; expanding foreign coverage (175 countries, 68 languages): Canada, United Kingdom, Latin America, Germany, Caribbean, Africa, Eastern Europe and Russia. Also, partner updates, including Google, AfricanLII, and Library of Congress. The principal business of the annual meeting was elections for LLMC's two governing bodies, our Board of Directors and Advisory Council. Voting rights for delegates reflected each library's subscription status relative to *LLMC Digital*.

◆ Elections 2022

In the Board of Directors election, two four-year slots were open due to the expired terms of **Richard Amelung**, Prof. Emer., Saint Louis U.L.L., and **Beth Williams**, Dir., Stanford U.L.L. The Board nominated **Lucy Curci-Gonzalez**, Exec Dir, NYLI and also nominated **Beth** to serve another term, especially in recognition of her experience as Chair of the Finance Committee and role leading the Technology Taskforce. The Board awarded **Richard** with Director Emeritus status in gratitude for 15 years' of consequential service as its Chair of the Board of Directors! **Anne Matthewman**, Dir., Dalhousie was elected by the Board to be the next Chair. **Ronald Wheeler**, Dir., Boston U.L.L. was invited by the Board to serve the remainder of David Gee's term due to his retirement. Board nominees were elected by electronic ballot.

In the Advisory Council elections, four councilors' terms expired. Two were nominated to serve another term and reelected by electronic ballot: **Jolande Goldberg**, Sen. Cat.-Policy Spec., Library of Congress and **Sara Sampson**, Dir, The Ohio State U.L.L. In addition, the Board nominated **Kincaid Brown** Director, University of Michigan L.L., **Helen Garner** Bodleian Law Librarian, Oxford University. Board nominees were elected by electronic ballot.

Our full leadership for 2022/23 appears below. We extend our sincere appreciation to the former councilors – **Kent Olson** and **Michelle Pearse** -- who have contributed their time and expertise as they have been instrumental in providing important content, counsel, and oversight to LLMC over the years.
